CODE OF CONDUCT

This Code of Conduct identifies the standard of behavior that is expected of all Ottawa Jr. 67's "AAA" Hockey Club members, including athletes, coaches, parents, directors and volunteers.

The Ottawa Jr. 67's "AAA" Hockey Club is committed to providing a sport environment in which all individuals are treated with respect. Members of the Ottawa Jr. 67's "AAA" Hockey Club shall conduct themselves at all times in a fair and responsible manner. Members shall refrain from comments or behaviors that are violent, disrespectful, offensive, abusive, racist or sexist. In particular, conduct that constitutes harassment or abuse will not be tolerated by the Ottawa Jr. 67's "AAA" Hockey Club.

During the course of all Ottawa Jr. 67's "AAA" Hockey Club activities and events, members shall avoid behavior that brings disrepute to the organization or the sport of hockey, including but not limited to abusive or illegal use of alcohol or non-medical use of drugs.

Ottawa Jr. 67's "AAA" Hockey Club members shall at all times adhere to their home association, District, and Ottawa District Minor Hockey Association (ODMHA) operational and discipline policies and procedures, to rules governing events and activities and to rules governing any competitions in which the member participates on behalf of the Hockey Club.

Ottawa Jr. 67's "AAA" Hockey Club members shall not engage in any activity or behavior that interferes with a competition or with any athlete's preparation for a competition, or which endangers the safety of others.

Failure to comply with the Code of Conduct may result in disciplinary action in accordance with the policies of the appropriate District and ODMHA. Such action may result in the member losing the privileges that come with membership in their home association, including suspension of player's hockey activities or, in the case of parent, that parent's access to arena for games and practices. As well, the opportunity to participate in other activities of the Hockey Club and potentially the privilege of being a member in their home association, District, and ODMHA could be adversely affected.
